1. Basis of contract

4. Delivery of products

4.1. Unless otherwise agreed in the order acknowledgement, you will collect the products from us on the date we notify you that they will be ready for collection. Risk in the products will transfer to you when the products are loaded onto your transport.

4.2. If we agree to deliver the product(s) to you or to a third party site at your request, delivery details will be included on the order acknowledgement or otherwise confirmed in writing between us. Risk in the products will pass to you once we deliver the products to the delivery location stated in the order acknowledgement.

4.3. Once we deliver the products to you, or to the third party to whom you requested we make delivery to, you are responsible for insuring them once we complete the delivery at the relevant location.

4.4. If you fail to take or accept delivery of the products or fail to collect the products within 30 days of us notifying you that they are ready, or if you fail to provide us with adequate delivery instructions or suitable facilities for the delivery of the products:

4.4.1. Delivery of the products shall be deemed to have been completed at 9am on the day following the end of the 30 day period; and

4.4.2. We may store the products until actual delivery or collection takes place and charge you for all related costs and expenses (including insurance).

4.5. Any time or dates quoted for delivery of the products are approximate only and time for delivery is not of the essence.

4.6. If we fail to deliver the products, our liability is limited to the costs and expenses incurred by you in obtaining replacement goods of similar description and quality in the cheapest market available, less the price of the products which you ordered from us.

4.7. 7.3.2. Shall not use the trade marks as part of the name under which you conduct your business, or any connected business, or under which it sells or services any products (except the products), or in any other way, except as expressly permitted under these terms.

7.4. You will not, without our prior written consent:

7.4.1. Alter or make any addition to the labelling or packaging of the products displaying the trade marks;

7.4.2. Make any addition or modifications to the products or to any advertising and promotional materials supplied by us; or

7.4.3. Alter, deface or remove any reference to the trade mark, any reference to us or any other name attached or affixed to the products or their packaging or labelling.

7.5. You must use only our approved marketing materials. Alterations to these materials are not permitted without our prior written permission.

8. Information & support

8.1. We shall provide you with such information, training and support as we, in our sole discretion, consider appropriate to enable you to discharge your duties under these terms properly and efficiently. However, any such information, training and/or support shall not relieve you of your obligations under these terms and you are solely responsible for all decisions and actions you make relating to the sale and installation of the products.

8.2. From time to time, we may request to contact your end customers to whom you have sold the products for the purposes of checking the quality of the end customer's experience and/or to ask for product reviews. You will use your reasonable endeavours to facilitate such customer feedback.

9. Warranty

9.1. We confirm that the products will conform in all material respects with their specifications (as detailed in the order acknowledgement) and be free from material defects in design,

time of discovery that some or all of the products do not comply with the warranty set out in clause 9.1;

9.2.2. We are given a reasonable opportunity to examine the products; and

9.2.3. You (if asked to do so by us) returns such products to our place of business at your cost,

We will, at our option, repair or replace the defective products, or refund the price of the defective products in full.

9.3. If we inspect the products and there is no fault for which we are responsible, we reserve the right to charge you our costs of carrying out the investigation.

9.4. We will not be liable for the products' failure to comply with the warranty set out in clause 9.1 if:

9.4.1. You or your end customer makes any further use of such the products where we tell you not too after you gave us notice in accordance with clause 9.2;

9.4.2. The defect arises because you or your end customer has failed to follow our oral or written instructions as to the storage, commissioning, installation, use or maintenance of the products or (if there are none) good trade practice regarding the same;

9.4.3. You or your end customer alters or repairs such products without our written consent;

9.4.4. The defect arises as a result of fair wear and tear (including, without limitation damage caused by blocked rainwater gutters/downpipes, which should be cleaned at least annually), damage (including damage caused by unusual or extreme weather, or storm damage in excess of the limits set out in the product specification, or in any project-specific calculations provided by us), negligence, or abnormal storage or usage conditions; or

10. Product Recalls

11. Confidentiality

11.2.1. to its employees, officers, representatives, contractors, subcontractors or advisers who need to know such information for the purposes of exercising the party's rights or carrying out its obligations under or in connection with these Terms. Each party shall ensure that its employees, officers, representatives, contractors, subcontractors or advisers to whom it discloses the other party's confidential information comply with this clause 11.3; and

11.2.2. as may be required by law, a court of competent jurisdiction or any governmental or regulatory authority.

11.3. No party shall use any other party's confidential information for any purpose other than to exercise its rights and perform its obligations under or in connection with these Terms.

12. Compliance

12.1. Each party shall at its own expense comply with all laws and regulations relating to its activities under these Terms, as they may change from time to time, and with any conditions binding on it in any applicable licences, registrations, permits and approvals.

13. Limitation of Liability

13.1. Nothing in these Terms limits any liability for:

13.1.1. death or personal injury caused by negligence;

13.1.2. fraud or fraudulent misrepresentation; or

13.1.3. defective products under the Consumer Protection Act 1987;

13.1.4. any liability that legally cannot be limited.

13.2. Subject to clause 13.1, we shall not under any circumstances whatever be liable to you, whether in contract, tort (including negligence), misrepresentation, restitution or otherwise, for:

13.2.1. any loss of profit, revenue, or anticipated savings, loss of sales, loss of business, loss of agreements or contracts, business interruption, loss of use of any equipment, loss of any contract or other business opportunity, loss of or damage to goodwill; or

13.2.2. any loss that is an indirect or secondary consequence of any act or omission of the party in question.

13.3. Subject to clause 13.1, and except as expressly stated in these Terms, all warranties, representations, terms, conditions, and duties implied by law relating to fitness, quality and/or adequacy are excluded to the fullest extent permitted by law.

13.4. Subject to clause 13.1, clause 13.2, and clause 13.3 our total liability to you shall not exceed the amount paid or payable by you to us under the relevant Order Acknowledgement to which the claim relates.

14. Termination

14.1. Once we have issued an Order Acknowledgement you may not cancel the order. If you request to make changes to the order following an Order Acknowledgement, such changes will only take effect if we each agree in writing and our consent to any such change is conditional on you agreeing to pay any costs incurred by us in relation to accepting the change.

14.2. Without limiting its other rights or remedies, we may cancel any Order Acknowledgement and/or terminate any rights which you have under these Terms with immediate effect by giving you written notice if:

14.2.1. you fail to pay any amount due under these Terms on the due date for payment;

14.2.2. you commit a material breach of any term of these Terms and (if such a breach is remediable) fails to remedy that breach within 7 days of that party being notified in writing to do so;

14.2.3. you take or have taken against you (other than in relation to a solvent restructuring) any step or action towards entering bankruptcy, administration, provisional liquidation or any composition or arrangement with your creditors, apply to court for or obtaining a moratorium under Part A1 of the Insolvency Act 1986, are being wound up (whether voluntarily or by order of the court), are being struck off the register of companies, have a receiver appointed to any of your assets, or (being a partnership) have any partner to whom any of the foregoing apply;

14.2.4. you (where you are purchasing as a sole trader, not through a limited company) are the subject of a bankruptcy petition or order;

14.2.5. you (where you are purchasing as a sole trader, not through a limited company) die or, by reason of illness or incapacity (whether mental or physical), are incapable of managing your own affairs or become a patient under any mental health legislation;

14.2.6. you suspend, threaten to suspend, cease or threaten to cease to carry on all or a substantial part of your business; or

14.2.7. your financial position deteriorates so far as to reasonably justify the opinion that its ability to give effect to the terms of these Terms is in jeopardy.

14.3. Without limiting its other rights or remedies, the Supplier may terminate these Terms with immediate effect by giving written notice to you if you fail to pay any amount due under these Terms on the due date for payment.

14.4. On termination of these Terms for any reason:

14.4.1. you will immediately pay us all of your outstanding unpaid invoices and interest and, in respect of products supplied but for which no invoice has been submitted, we may submit an invoice, which shall be payable by the you immediately on receipt;

14.4.2. if you fail to pay us, we may enter the premises where

you are storing the products and take possession of them;

14.4.3. your rights to use our trade mark, and any marketing and/or sales materials relating to our products will cease immediately.

14.5. Termination of these Terms, however arising, shall not affect any of the parties' rights and remedies that have accrued as at termination, including the right to claim damages in respect of any breach of these Terms which existed at or before the date of termination.

14.6. Any provision of these Terms that expressly or by implication is intended to come into or continue in force on or after termination of these Terms shall remain in full force and effect.

15. Data Protection

15.1. Each party will comply with UK data protection legislation when performing its obligations under these Terms.

15.2. Where we process your personal data, and any End Customer Personal Data (as defined below in clause 15.4), we will do so in accordance with our privacy policy, which you can find on our website.

15.3. If you provide us with any personal data in connection with these Terms (including End Customer Personal Data and end customer personal data to facilitate the delivery of the product to them), you represent and warrant that you have all necessary notices and consents in place to enable the provision of the data to us for our use in connection with the performance of these Terms. You also confirm that any personal data (including End Customer Personal Data) you provide to us will be complete and accurate and that you will notify us if it becomes out of date or if it requires correction.

15.4. In this clause, End Customer Data means the personal data (name, address, email address and/or telephone number) of any of your end customers where you share this with us so that we can carry out quality assurance reviews of your work and to obtain product reviews from the end customers (the "Purpose").

15.5. You agree that you will use all reasonable endeavours to seek permission from your end customers to lawfully enable the transfer of their End Customer Data to us for the Purpose. We will only use the End Customer Data for the Purpose.

15.6. You will indemnify us against all liabilities, costs, expenses, damages and losses (including but not limited to any direct, indirect or consequential losses, loss of profit, loss of reputation and all interest, penalties and legal costs (calculated on a full indemnity basis) and all other reasonable professional costs and expenses) suffered or incurred by us arising out of or in connection with your breach of any UK data protection legislation.

16. Other important terms and conditions

16.1 Neither party shall be in breach of these Terms or otherwise liable for any failure or delay in the performance of its obligations if such delay or failure results from events, circumstances or causes beyond its reasonable control. The time for performance of such obligations shall be extended accordingly. If the period of delay or non-performance continues for six months, the party not affected may terminate these Terms by giving 30 days' written notice to the affected party.

16.2. You may not subcontract any or all of its rights or obligations under these Terms without our prior written

consent. If we consent to any subcontracting, you shall remain responsible for all the acts and omissions of your subcontractors as if they were your own.

16.3. If any provision of these Terms shall be found by any court or administrative body of competent jurisdiction to be invalid or unenforceable, the invalidity or unenforceability of such provision shall not affect the other provisions of these Terms and all provisions not affected by such invalidity or unenforceability shall remain in full force and effect.

16.4. No implied waiver by the parties of any breach by the other of the provisions of these Terms shall operate as a waiver of any preceding or successive breach of the same or of any other provisions of these Terms.

16.5. Any variation of these Terms shall only be effective if set out in writing and signed by the parties (or their authorised representatives).

16.6. Nothing in these Terms is intended to, or shall be deemed to, establish any partnership or joint venture between any of the parties, constitute any party the agent of another party, or authorise any party to make or enter into any commitments for or on behalf of any other party.

16.7. Each party confirms it is acting on its own behalf and not for the benefit of any other person.

16.8. No one other than a party to these Terms, their successors and permitted assignees, shall have any right to enforce any of its terms.

16.9. These Terms contains the entire agreement between the parties pertaining to its subject matter and supersedes and cancels any prior agreements and understandings and any amendment to this agreement shall be in writing signed by both parties.

16.10. Any notice given to a party under or in connection with this agreement shall be in writing and shall be:

16.10.1. delivered by hand or by pre-paid first-class post or other next Business Day delivery service at its registered office address; or

16.10.2. sent by email to the address to the email addresses stated in the Order Acknowledgement (unless otherwise agreed in writing).

16.11. Any notice shall be deemed to have been received:

16.11.1. if delivered by hand, at the time the notice is left at the registered office address;

16.11.2. if sent by pre-paid first-class post or other next working day delivery service, at 9.00 am on the second Business Day after posting; or

16.11.3. if sent by email, at the time of transmission, or, if this time falls outside business hours in the place of receipt, when business hours resume. Business hours means 9.00am to 5.00pm Monday to Friday on a Business Day.

16.12. Clauses 16.10 and 16.11 do not apply to the service of any proceedings or any documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.

16.13. These Terms are governed by and construed in accordance with the laws of England and the parties hereby submit to the exclusive jurisdiction of the English courts.
